



## Conclusions and Recommendations

In view of the current global political landscape, marked by ideological, religious, economic, and political conflicts, there is an urgent need for establishing harmony and peaceful coexistence in the world. The following key conclusions and recommendations emerged from the conference for the kind attention of all people and rulers and for immediate action:

### Global Leadership for Peace

Former White House Chief Administrative Officer, Mr. Scot Faulkner, strongly advocated for a trilateral collaboration between India, Russia, and the United States. He emphasized the potential of these nations to lead the world toward lasting peace and harmony by uniting science and spirituality as the foundational pillars of a new global order.

### Holistic Medicine through Green Nanotechnology

Prof. Dr. Kattesh Katti, renowned as the Father of Green Nanotechnology from Columbia, Missouri, highlighted the transformative potential of nanotechnology-based Ayurvedic medicine. He recommended its adoption as a holistic and cost-effective approach to healthcare, particularly in response to the rising cost of global medical treatment. The conference endorsed the integration of advanced biotechnology, particularly Nutrigenomics and Nano Green Technology, to safeguard the biosphere and ensure a sustainable future for the planet.

### International Artificial Intelligence Corporation

A proposal was put forth to establish an international body named “Markov International Artificial Intelligence Corporation”, in honour of Markov’s foundational contributions to mathematics and logic, which underpin modern AI systems.

### Global Academic Enhancement in Advanced Technologies

Technical papers from distinguished scientists representing Russia, Mexico, Syria, the U.S., Singapore, and India underscored the importance of incorporating advanced technologies into global academic curricula, ensuring the next generation is well-equipped to drive innovation and progress.

### Spiritual Guidance for Global Harmony

Spiritual leaders from India, the World Philosophical Forum, and other organizations played a vital role in the deliberations. They collectively emphasized that spiritual wisdom must guide scientific advancement to foster global harmony and peace.

### Science and Spirituality: A Unified Path Forward

The overarching message of the conference was clear: lasting peace and sustainable coexistence can only be achieved when science and spirituality work hand in hand. This synergy is essential for building a balanced and compassionate global society.
